

**HERSHEY'S/ FAMILY DOLLAR REESE'S LOVERS SWEEPSTAKES  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. SWEEPSTAKES ENTRY PERIOD BEGINS AT 12:00:01 PM ET ON MAY 1, 2020 AND ENDS AT 11:59:59 PM ET ON JUNE 6, 2020 (THE "SWEEPSTAKES ENTRY PERIOD") SWEEPSTAKES ONLY OPEN TO LEGAL RESIDENTS OF THE UNITED STATES RESIDING IN THE 50 UNITED STATES AND DISTRICT OF COLUMBIA, WHO ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED.**

**1. HOW TO ENTER: NO PURCHASE NECESSARY TO PARTICIPATE IN**

**SWEEPSTAKES.** Visit <https://FDReesesLovers.com> (the "Website") during the Sweepstakes Entry Period and follow the online instructions to complete the Official Online Entry Form, submit as instructed to register for the Sweepstakes, and vote for your favorite REESE'S product (a purchase is not required). Upon the successful submission of the registration information on the entry form, an entrant will receive one entry into the Sweepstakes. Online entries must be received by no later than 11:59:59 PM ET on June 6, 2020 to be eligible to win the prizes offered. Limit one entry per name per e-mail address per day. The Hershey Company's ("Sponsor") computer is the official time keeping device for this Sweepstakes. Proof of e-mailing does not constitute proof of delivery or entry. Any attempt to submit more than the maximum number of entries using multiple/different email addresses, identities or any other methods may void that entrant's entry. Entries generated by a robotic, programmed, script, macro or other automated means will be disqualified. No other forms of entry are valid other than those set forth above. All entry information becomes the property of the Sponsor.

Once the text message is received, the entrant will automatically receive a text message with a link to the Website. The entrant may log on to the Website in his/her browser and follow the entry steps set forth in this Section 1 to enter. Each text message must be manually key-stroked/entered by the entrant. An entrant is not required to send a text message to participate and may go directly to the Website to enter. By texting the Keyword to the Short Code, you provide to the Sponsor and Administrator your express written consent to receive text messages using automated technology.
